



Release, Waiver, Indemnity and Acknowledgement

IN CONSIDERATION OF the Halton Regional Police Service granting permission to participate in the Youth Equity, Diversity and Inclusion Program (hereinafter “Youth EDI Program”), **I** _____, **HEREBY RELEASE, WAIVE AND FOREVER DISCHARGE** The Regional Municipality of Halton, the Halton Regional Police Service, The Regional Municipality of Halton Police Services Board and their respective agents, elected and appointed officials, employees, contractors, and representatives (collectively referred to as “the Releasees”), from all claims, demands, damages, costs, expenses, actions, and causes of action, whether in law or equity, in respect of death, injury, loss or damage to my person or property, howsoever caused, arising or to arise by reason of participation in the Youth EDI Program, including any not now known or anticipated, but which may arise in the future and all effects and consequences thereof.

AND FOR SAID CONSIDERATION, the Releasor further agrees not to make any claim or take any proceedings against any other person or corporation who might claim contribution or indemnity under the provisions of the *Negligence Act* and the amendments thereto from the person, persons or corporations discharged by this Release.

AND FOR SAID CONSIDERATION, the Releasor agrees and undertakes to at all times indemnify and save harmless the Releasees against and from any and all actions, causes of action, suits, claims and demands whatsoever which have been, are being made or may be made by the Releasor or on behalf of any person under the *Family Law Act*, and the amendments thereto, and any similar legislation, for damages, loss or injury, interest and costs. Without limiting the generality of the foregoing, the Releasor agrees and undertakes to indemnify and save harmless the Releasees from any subrogated claim(s) which could be advanced by the Releasor’s insurer(s) in respect of the matters described herein.

I UNDERTAKE AND AGREE TO COMPLY with all regulations, directions, and requirements of the Halton Regional Police Service and to obey the orders, rules and directions given to me by any one of them.

I FURTHER UNDERSTAND, AGREE AND ACCEPT THAT any permission granted to me, including permission to attend the Youth EDI Program may be revoked at any time by any member

of the Halton Regional Police Service for any reason and that I am not entitled to any explanation for said revocation.

I ACKNOWLEDGE THAT the Halton Regional Police Service may use photographic and video materials from the Youth EDI Program and may take my picture for future use in promotional materials (for example: the Burlington Post, Cogeco, CHCH TV – Police related brochures, displays, website, etc). I grant to the Halton Regional Police Service all rights, title and interest in and to the photographs and or videos and the resulting copies or reproductions of the images taken of me during my participation in the Youth EDI Program by the Halton Regional Police Service staff and/or local media.

I AGREE THAT the Halton Regional Police Service has the exclusive right to use the images for use in promotional or educational materials described above. I also agree that the Halton Regional Police Service may publish my name when distributing the above mentioned promotional or educational materials.
